NEW JERSEY METRICS AT CLOSE OF BUSINESS, NOVEMBER 14, 2012

ALL 21 NEW JERSEY COUNTIES NOW APPROVED FOR FEDERAL ASSISTANCE

On October 30, President Obama signed a major disaster declaration for the state of New Jersey due to damage caused by Hurricane Sandy. Families and individuals in all 21 counties are eligible for Individual Assistance for residents who sustained damage from Sandy and Public Assistance (7 categories) that helps repair or replace public infrastructure and facilities.

Support includes grants to cover temporary housing and serious disaster-related needs and reimbursement for expenses not covered by insurance or other assistance programs.

REGISTER FOR FEMA DISASTER ASSISTANCE

Residents who suffered disaster-related damage or loss should register for federal and state disaster aid. Registration may be completed online at www.DisasterAssistance.gov, by smartphone through m.fema.gov, or by calling FEMA's toll-free registration line at 1-800-621-FEMA (3362). Residents with a speech disability or hearing impairment who use a TTY may call 1-800-462-7585 directly; users of 711 or video Relay Service (VRS) may call 1-800-621-3362. Multi-lingual operators are available. Telephone registration is available daily from 7 a.m. to 10 p.m., until further notice.

When registering for assistance, it is helpful to have the following information available:

- Current telephone number
- Address at the time of the disaster and current address
- Social Security number
- A general list of damages and losses
- If insured, the name of the insurance company, agent and policy number
- Bank routing number and account number for direct deposit of assistance grants

BEWARE OF RUMORS AND SCAMS AFTER HURRICANE SANDY

Rumors are circulating that those impacted by Sandy can obtain \$300 vouchers. They are **NOT** true!

Disaster recovery officials caution residents to be alert for scam artists using old and new tricks to obtain vital information or take advantage of storm-weary survivors, including identity theft, false payment claims, bribes, home repair scams, price gouging and false charities.

SIX BUSINESS RECOVERY CENTERS OPEN

Small Business Administration representatives are on duty at all Disaster Recovery Centers to assist business owners who incurred losses from Hurricane Sandy. In addition SBA has opened six Business Recovery Centers (listed below) to provide personal assistance to individuals and operators of small businesses with their SBA applications. All but two centers are open weekdays from 9 a.m. to 5 p.m.; some will operate additional hours.

SBA ASSISTANCE FOR RENTERS AND HOMEOWNERS

SBA offers long-term, low-interest loans directly from the U.S. Treasury to repair or replace real estate or personal property damaged or destroyed in a disaster. These loans are available to **homeowners**, **renters**, **businesses of all sizes and private**, **non-profit organizations**.

Renters and homeowners must first register with FEMA; if they are referred to SBA, they then must complete an SBA application that will permit SBA to determine if an applicant qualifies for an SBA loan or possible further FEMA grants.

LOANS FOR PROPERTY DAMAGE

Businesses of any size and private, non-profit organizations may borrow up to \$2 million to repair or replace disaster-damaged real estate, machinery and equipment, inventory and other business assets.

ECONOMIC INJURY DISASTER LOANS (EIDLS)

Small businesses, small agricultural cooperatives, small businesses engaged in aquaculture, and most private, non-profit organizations of any size may borrow to help meet working capital needs caused by the disaster (regardless of whether the business suffered any property damage). The maximum business disaster assistance loan from SBA is \$2 million for any combination of property damage and economic injury.

LOANS FOR RESIDENTS (your employees impacted by the disaster)

Homeowners may borrow up to \$200,000 to repair or replace their disaster-damaged primary residence. Homeowners and renters may borrow up to \$40,000 to replace disaster-damaged personal property, including vehicles. Interest rates can be as low as 1.688 percent for homeowners and renters, 4 percent for businesses and 3 percent for private non-profit organizations. Terms may be up to 30 years, SBA determines loan amounts and terms based on each applicant's financial condition.

FEMA'S PRIVATE SECTOR DIVISION

GETTING ACQUAINTED

FEMA established the Private Sector Division (PSD) within the Office of External Affairs in October 2007. The division's overarching goals include improving information sharing and coordination between FEMA and the private sector during disaster planning, response and recovery efforts. The FEMA PSD cultivates public-private collaboration and networking in support of the various roles played by the private sector in emergency management. The division also fosters internal collaboration and communication among FEMA programs that have an interest in private sector engagement.

PSD Purpose Statement

"Communicate, cultivate and advocate for collaboration between the U.S. private sector and FEMA, to support FEMA's capabilities and to enhance national preparedness, protection, response, recovery, and mitigation of all hazards."

PSD Services:

- Help integrate the private sector into the response by providing an entry point for private sector inquiries and
 offers of assistance.
- Collaborate with federal partners, such as the Small Business Administration and others to bring timely, relevant disaster information on services, resources and opportunities to private sector entities in the impacted area.
- Work with state and local organizations on roundtables, meetings and other informational events to help speed private sector recovery.
- Publish E-news Updates and Business Advisories to communicate disaster recovery information and relevant federal assistance programs to private sector organizations.
- Elevate major or emerging private sector recovery issues to FEMA and other government officials for resolution.

TRANSITIONAL SHELTERING AVAILABLE

FEMA has activated its Transitional Sheltering Assistance (TSA) program for eligible disaster survivors who are unable to return to their homes for an extended period of time and need shelter to stay in a participating hotel or motel. Hotel and motel owners interested in participating in TSA may register at ela.corplodging.com/.

LOCAL DISASTER RECOVERY CENTERS (DRCs) OPEN IN NEW JERSEY

The state of New Jersey in partnership with the Federal Emergency Management Agency (FEMA) has opened Disaster Recovery Centers (DRC) and Mobile Disaster Recovery Centers (MDRC) to help people whose homes or businesses were affected by Hurricane Sandy. The centers are staffed by representatives from state, federal and voluntary agencies who can provide information on disaster assistance programs and answer questions.

DRCs are open from 8 a.m. to 8 p.m., seven days a week – unless otherwise indicated. Mobile DRCs may be set up as needed. Residents can locate the nearest DRC at: asd.fema.gov/inter/locator/home.htm. Depending on need, centers may be added or closed.

At the center, visitors:

- Receive information about state and federal disaster assistance.
- Get help with applications for U.S. Small Business Administration low-interest disaster loans for homeowners, renters, businesses of all sizes and private nonprofit organizations.
- Inquire about the status of their applications for federal assistance.
- Obtain referrals to voluntary organizations that help with immediate unmet needs.
- Learn cost-effective measures to reduce the impact of future disaster losses.
